### Call to Order

The meeting of the General Membership of Pasadena Showcase for the Arts was held at the Pasadena Senior Center. Donna Gotch, President, called the meeting to order at 9:20 a.m. Beverly Muench, Secretary, was present.

#### Quorum

There were 34 voting members present.

### **Approval of Minutes**

Ms. Graham moved and Ms. Tyler seconded to approve the minutes of the January 8, 2014 General Membership meeting. Motion carried.

### **Officers Reports**

#### President: Donna Gotch

Ms. Gotch welcomed members to the Pasadena Senior Center and provided a brief overview of the center. She then introduced Hye-Ryung Lim, the Grand Prize winner of the 28<sup>th</sup> PSH Instrumental Competition, who together with her accompanist, proceeded to perform for the membership.

### 1<sup>st</sup> Vice President: Katherine Watkins

Ms. Watkins announced that there had been a delay in distributing the proposed Bylaw changes approved by the Board of Directors to the membership, and the required 10-day notice requirement was not met. Therefore, those changes will be presented for approval at the March General meeting. She then reported the changes to the Policies and Procedures Manual approved by the Board of Directors to 1) recognize members for consecutive years as Active and Business members, 2) increase the amount required for bids, and 3) clarify the voting privileges of the President and the Advisor/Parliamentarian. The specific changes approved are as follows:

- 1) Page 54 effective July 1, 2014
- 25. MEMBERSHIP CHAIR
  - Shall present and coordinate recognition of members on their tenth, fifteenth and twentieth consecutive year anniversaries of Active and Business membership, including the Provisional year, at a General Meeting.
- 2) Page 50 effective July 1, 2014
- 17. BIDS AND WAIVERS
  - All anticipated expenditures of \$7,500-\$10,000 or more shall require bids from three (3) vendors unless waived by the Finance Committee.
- 3) Page 52
- 20. PRESIDENT
  - Shall maintain neutrality when presiding at Board of Directors and General Meetings and only vote in the case of breaking a tie, causing a tie or a ballot vote. The President
