First Vice President Eileen Reilly 2021 has been a fairly busy year for the Policies & Procedures Committee. We dealt with several Issue Papers and made recommendations to the Board, which resulted in changes to the Articles of Incorporation, Bylaws, Policies and Procedures Manual and Board and Benefit Committee Job Descriptions, as well as the Gifts & Grants Guidelines. Those changes can be found on the PSHA website thanks to our Publications Chair, Cathy Hilton, who does a great job of keeping things current!

In summary, however, the changes are as follows:

- Article TWO B of the Articles of Incorporation will be amended to say the support area for music programs will be the County of Los Angeles with special consideration being to the greater Pasadena area of California. This change reflects the results of the membership survey in which more than 2/3 of those who responded were in favor of such consideration. The amended Articles will be filed with the state in the near future.
- Article II Purposes, Section 1. of the Bylaws has been changed as indicated:

To support music programs in the County of Los Angeles with special consideration given to the greater Pasadena area of California.

- Changes have been made to the Policies and Procedures Manual and Job Descriptions with regard to the responsibilities of Board and Benefit Hospitality Chairs to prepare information for General, Board, and Benefit Committee meetings and for the Publications Chair to send meeting notices.
- Section 11 of the Policies and Procedures Manual, Marketing Policy, was amended to require prior Board approval for any exclusive access by media to the House if it excludes other media from covering the House and requiring prior Board approval for any sponsorship packages.
- Section 11 of the Policies and Procedures Manual, Marketing Policy, and Section 35 of the Policies and Procedures Manual, Publications Chair, were amended to say that credit should be given to G & G recipients when PSHA uses their images on its website, in Press Releases, in Media Packets, or in its Program.
- Section 78 of the Policies and Procedures Manual, Criteria for Distinguished Service Award, was amended to require service on a permanent basis for 10 years, rather than 5 years.
- The Gifts & Grants Committee Guidelines will be amended: (1) to reflect the revised support area for music programs; (2) to allow committee members to do face to face or virtual interviews where required; and (3) to define the greater Pasadena area of California as including: Pasadena; Alhambra; Altadena; Arcadia, including unincorporated area; Burbank; Eagle Rock; East Pasadena, including unincorporated area; El Sereno; Glendale; Highland Park; La Canada Flintridge; La Crescenta/Montrose, including unincorporated area; Monrovia, including unincorporated area; Monterey Park; San Gabriel, including unincorporated area; South Pasadena; and Temple City.
