The Policies & Procedures Committee, which I have the pleasure of chairing this year, is responsible for considering recommendations for changes to how PSHA operates. The Committee's approved recommendations are then presented to the Board. This includes changes to our Bylaws, a required governing document for all corporations, as well as our manuals and guidelines which incorporate practices and policies on a variety of topics, including policies necessary to maintain our non-profit status,

financial policies, and guidelines for our music programs and standing committees. If you run across a policy that doesn't seem to work for your current circumstances, you should know that many policies can be amended, modified and/or waived by our Board. Bylaw provisions, on the other hand, can only be amended by a vote of the membership. Every member's input is important. Any member with a suggestion for amending, waiving or changing any of our policies should let me know, and I will work with you to get that suggestion on the Committee's agenda. Suggestions can be made anonymously so they can be considered on their merits.

The First Vice President is also responsible for overseeing PSHA's grant requests. We have two grant requests pending: one was submitted to the Green Foundation and requests support for our Youth Concert, the second was submitted to the State of California which has funds available for non profit arts organizations impacted by the coronavirus.

This is the third PSHA position I've held where I've followed Eileen Reilly, and I couldn't have a better mentor. Her reports are thorough and accurate; she has been extremely helpful in getting me up to speed on the myriad of responsibilities this position entails. Thank you, Eileen.
