# 1st VP Policies and Procedures

The Policies & Procedures Committee undertook the process of implementing recommendations from the Organizational Advancement Committee (OAC) appointed by last year's President, Barbara Damerel, and chaired by Matt McIntyre. This necessitated changes to our Bylaws and policies. The specific policies needed that needed to be changed and the language to do so was discussed and approved first at meetings of the Policies & Procedures Committee, then by our Board, and all changes have now been approved by the membership at the January General Meeting.

One recommendation required an amendment to Article III, Section B. Applications for a Provisional Member. The OAC recommended that membership applications be submitted throughout the year instead of having the June Board meeting be the cutoff date each year. The Bylaw now provides that applications approved by the Membership Committee are to be submitted for approval to the Board at meetings from June through January of the following year. This maintains a cohesive class of new members each year but still provides for flexibility in accepting new members.

The second OAC recommendation required an amendment to Bylaw Article III, Section D. Membership

Descriptions, Benefits, and Requirements. The OAC recommended that the service requirement for Active members be reduced from ten Showcase shifts to eight and that members not have a separate prestaffing and Showcase staffing requirement. The OAC also recommended that the years of service for eligibility to become an Associate member be increased from six years to eight years. The OAC did not make a recommendation for member service requirements or years of eligibility for Business members, nor did it have a recommendation on the application of this change for current members who have varying years of service and categories of membership. These issues were discussed by the Policies & Procedures Committee; its recommendations were presented to the Board. The Bylaw amendment approved by the Board was approved by the membership at the January meeting.

The changes in membership service requirements will take effect for members joining PSHA in June 2022 and thereafter. The new service requirements will be: for New members and Active members – a total of ten shifts, which may be either pre-staffing, Showcase shifts, or a combination. A New Member or an Active member may buy out of four shifts. Eight years of Active membership are required to be eligible to become an Associate member. Members joining in 2022, who elect Business status after their first year, will have a service requirement of six shifts, which may be either pre-staffing or Showcase shifts. A Business member may buy out of three shifts and will need fourteen years as a Business member to be eligible to become an Associate member.

Current Active and Business members will have no changes to their membership service requirements, or years of service for Associate eligibility unless they are Active or Business members that have completed the years of service to be eligible for Associate membership. For those members, as of June 2022, they may avail themselves of the new service requirements. For current Active & Business members, as they complete the years of membership under the previous requirements, and if they continue as Active or Business members rather than electing Associate membership, they too may avail themselves of the new reduced service requirements.

A third Bylaw amendment of Article V Financial Policies, paragraph. 2. Season Tickets was also approved at the January General Meeting. The specific dollar amount for members to purchase tickets at Walt Disney Concert Hall or boxes at the Hollywood Bowl was removed from the Bylaw. The price will now be determined by the President and Season Ticket chair.

These Bylaw amendments and other amendments approved by the Board for the Policies & Procedures Manual will be uploaded to our website shortly. Members with questions about how the new membership service requirements will apply to them should feel free to contact me. And, as always, all members who have suggestions to change or improve our policies are encouraged to submit an issue paper for consideration by the Policies & Procedures Committee. A template for an Issue Paper is in the Members' section of our website. Issue papers can be presented anonymously so that the Committee's discussion would not be influenced by who authored it.

Members of our Policies and Procedures Committee undertook a big assignment this year and were dedicated and diligent in working through these proposals. Thank you to ex-officio members Marti Farley and Dotty Ewing, to elected members Susan Barilich, Jennifer Jones, Dana Marevich, and appointees, Lynne Graves & Debra Qurtman. Thanks also to the Board members whose thoughtful discussion at the Board meetings improved the final recommended Bylaw amendment. This organization has been improved by your efforts. We owe you all a debt of gratitude.

The Empty House Party, *Savor the Flavors of the World*, chaired by Kerri Terrill and Shari Domenghini under the "super" vision of event queen Marybeth Rehman-Dittu, took place on Friday, January 21. Operating under unique pandemic circumstances, the partying took place in the Welcome Garden under a fabulous crystal clear tent. The wine, donated by San Antonio Winery, flowed freely. Not even the gale force winds could blow the festivities. Over 350 guests feasted on sushi, Mexican food, Korean tacos, desserts, and more. Caterers included Portos Bakery, Mijares Mexican Restaurant, Fish King, Kogi truck, and JR Party Planning.

Lisa Loeffler arranged a perfect parking location in Alhambra and the shuttles that carried our guests.

We currently have 21 interior and exterior designers, with one more designer close to signing.

The Core team has begun staffing the house. Pre-staffing sign-ups for members will begin at the end of January/early February. Pre-staffing shifts will begin on February 14.
